Who We Are

The Global Ageing Network (GAN) is an international community of leaders in ageing services, housing, research, technology, and design. We bring together experts from around the world, lead education initiatives, and provide a place for innovative ideas in senior care to be born and shared. We pave the way to improve best practices in aged care so that older people everywhere can lead healthier, safer, and more independent lives. GAN has grown from an idea to a vibrant network spanning nearly 60 countries serving millions of people every day.

GAN is well-situated to become a global force for change in aged care providers. GAN member organizations range from small nursing homes in rural South Africa, to large multi-site faith-based organizations in Australia, to retirement communities in New Zealand, Canada, and the United States, to home care agencies in Ireland and around the world. The diversity of approach, services, cultural influences, and resources adds to the richness of the global network. It affords a tremendous opportunity to expand our thinking and learn from one another.

The core of the Network is made up of regional or country-based associations or organizations whose members are ageing service providers and who realize the importance of global connections in providing care for the elderly – as well as provider organizations, businesses, and other stakeholders. Among them are organizations in Australia, China, Malaysia, Korea, Europe, the United Kingdom, South Africa, Lebanon, Canada, and the United States.

Mission

The Global Ageing Network's mission is to connect and support care and service providers worldwide to enhance quality of life for ageing.

2022 Highlights

Reports

A "Cross Cultural Snapshot of the Vaccine Distribution: A Provider Perspective" report, conducted by Dr. Emi Kiyota, detailed key findings and important lessons from aging services providers in 12 countries during the COVID-19 vaccination roll-out. Across countries, vaccine availability was unreliable, prioritization was unclear, and the inequities in access and administration were significant.



STANDARDS WISE INTERNATIONAL Supporting Excellence in Senior Living and Human Services

The study was conducted with generous support from StandardsWise International, an Australian-based "thought leader" and champion of quality standards. As David Stevens, President and CEO of StandardsWise International noted, "studies

like this provide a hard body of evidence and context from which to build and, when added to the very practical provider experience, there is much we can learn and act upon."

Webinars

Creating an Age-Tech Ecosystem

JDC-Eshel, the largest Jewish humanitarian provider organization in the world, provided a modified bootcamp on how to create an Age-Tech Ecosystem in July 2022. An age-tech ecosystem includes cross-sectional stakeholders from the government, public, and private sectors who come together to create innovative and adapted solutions to the challenges of aging. JDC-Eshel has been a pioneer in Israel's entrepreneurship-technological sphere for the past 25 years and has created a successful partnership with the government in developing and implementing services for older adults in Israel. The webinar was sponsored by NJHSA and Selfhelp.





Opening Doors to Aging Services: A LeadingAge Initiative



Members participated in a May 2022 webinar to learn about LeadingAge's Opening Doors to Aging Services – a long-torm local-national initiative designed to raise awareness of term, local-national initiative designed to raise awareness of the

aging services sector. LeadingAge represents more than 5,000 nonprofit and mission-driven aging services providers in the United States. Opening Doors to Aging Services guidance and materials are applicable to all provider settings and for organizations of all sizes. Care Models and Strategies to Dementia Care: An International Perspective

We hosted a webinar in April 2022 focused on care models and strategies to improve dementia care, designed to share what advocates and stakeholders have learned and continue to learn about effective care and support for those living with dementia. <u>The Roadmap for Investment in Dementia Care</u>, created by the Milken Institute and the Alzheimer's Society, offered five opportunity areas where the government, philanthropy, and private capital can improve the quality of life for people living with dementia and their caregivers. Aging in America Webinar Series

Aging in America has been a long-time supporter and friend of the Global Ageing Network and is very familiar with the issues facing providers through its own experience



as well as its work at the United Nations. Aging in America sponsored three interactive and engaging virtual webinars which allowed participants to learn from a panel of experts, connect with one another and share insights.

Filling the Caregiving Gap: An International Perspective Webinar

We hosted a timely webinar on "Filling the Caregiving Gap," bringing perspectives from experts from the U.S., Canada, and Ireland in January 2022. Workforce is a global challenge, and the difficulties are particularly acute among frontline staff who provide 80% of the care. It was universally agreed that we need a strategic focus on workforce that is not only country-specific, but global.

"Ageism in Ageing Services: An International Perspective" Webinar

Participants from around the globe joined together in February 2022 in a discussion focused on "Ageism in Ageing Services." Ageism has become a normal part of our world; it is everywhere, so we no longer see it. Ageism pigeonholes people and assumes how people of a certain age should act and ignores the intersectionality of so many other factors.

The Nursing Home of the Future: An International Perspective Webinar

The final webinar of the series focused on "The Nursing Home of the Future: An international perspective" in March 2022 and highlighted innovative aged care homes of the future.

Peak Association Roundtables

To build strong partnerships across countries and regions, we hosted three roundtables, facilitated by Vic Rayner, CEO of the National Care Forum (United Kingdom) and Joseph Musgrave, CEO of HCCI (Ireland), with leaders of peak associations that are part of our Network. Each has been a substantive, timely and meaningful exchange which yields new insights, ideas, and appreciation for one another.

Support Older Adults in the Ukraine

International Psychogeriatric Association (IPA)



We were proud to support the International Psychogeriatric Association (IPA) campaign to raise awareness around the impact of ageism on health outcomes and to support the protection of human rights of older persons with mental health conditions. IPA used their platform to highlight both older persons' mental health, as well as promoting healthy ageing initiatives around the globe through Older Adult Mental Health Awareness Week, October 1-10.

The National Academy of Medicine Global Roadmap for Healthy Longevity



In November, we participated in the National Academy of Medicine's one-day symposium to explore the recommendations from the <u>Global Roadmap for Healthy</u> <u>Longevity report</u>. The report provides guidance to societies on how to create more years of good health through strengthening their social infrastructure, physical environment, health systems, and opportunities for education, work, and retirement.

United Nations Updates

Call for a Convention at the 12th Session of the UN Open Ended Working Group on Ageing (OEWGA)

After two years of limited participation and virtual meetings, the United Nations Open-Ended Working Group on Ageing (OEWGA) met in-person in April 2022 for the 12th working group sessions to strengthen the protection of the human rights of older persons. The Global Ageing Network served as an advocate for the interests and needs of our members and actively participated in UN-related events and discussions. NGOs and Member states have called out repeatedly for a legally-binding United Nations Convention on the Rights of Older Persons. The Global Ageing Network supports the development of a Convention.

United Nations International Day of Older Persons (IDOP)

We joined numerous aging organizations in October to celebrate the United Nations <u>International Day of Older Persons (IDOP)</u>. The theme for this year was "Digital Equity for All Ages," highlighting the need for access and connection virtually for older persons. Digital equity is all about a collective effort to democratize technology, and achieving it is a shared responsibility that includes friends and family.
